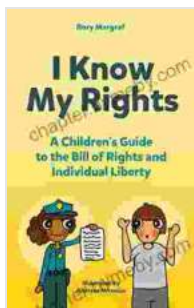

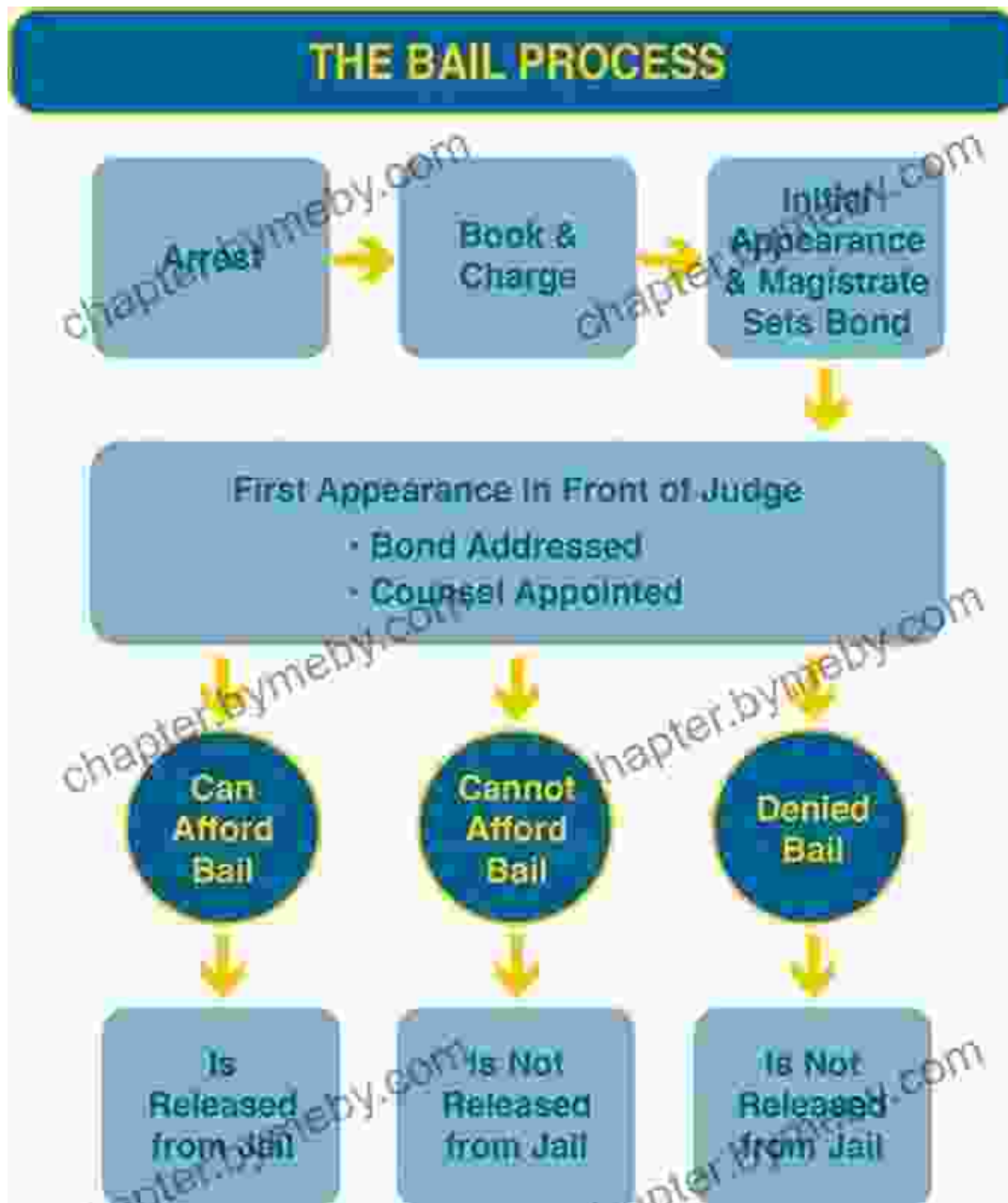


Civil Trials

- In civil court, a jury is comprised of six people. Juries are not often used in civil trials.
- The **plaintiff** presents his or her side of the story first and is followed by the **defendant**.
- Each party then summarizes, or provides a closing statement, to the judge and/or jury.
- A decision can be made to grant all, part, or none of the **plaintiff's claim**.

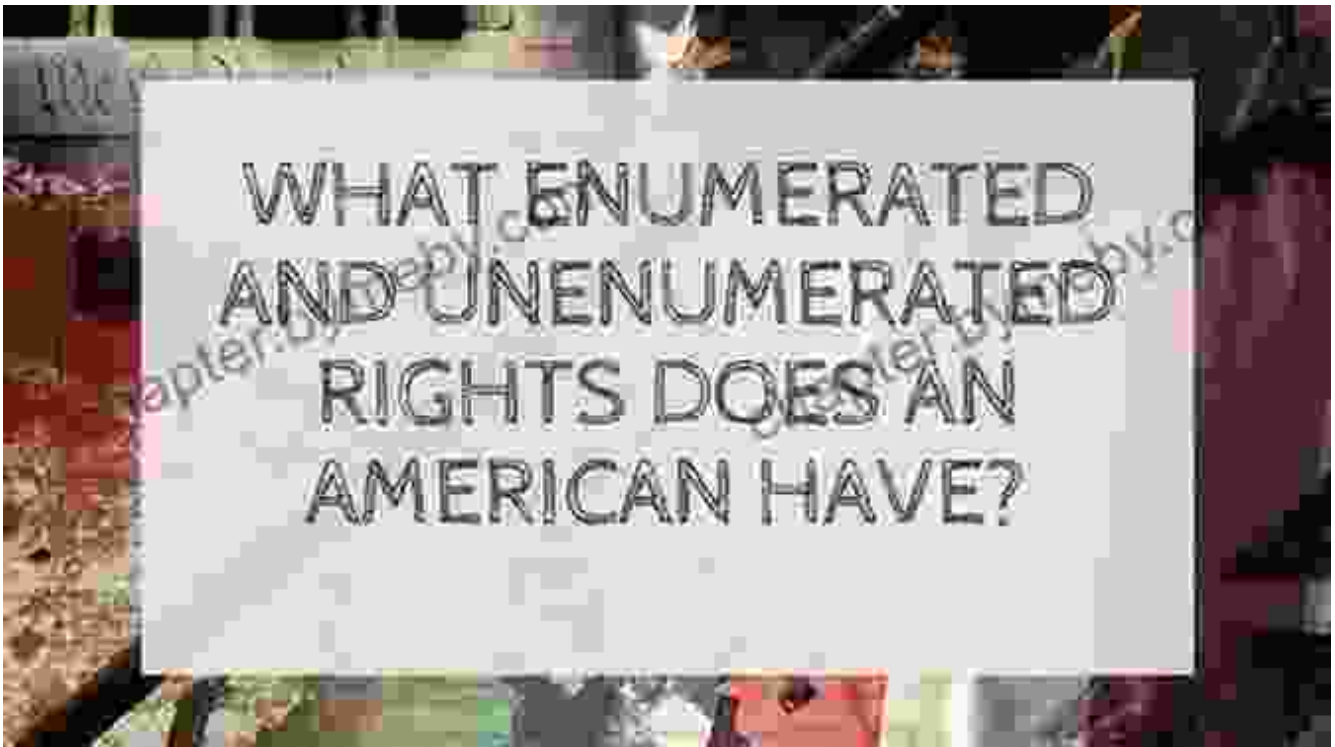
Amendment 8: No Excessive Bail or Fines

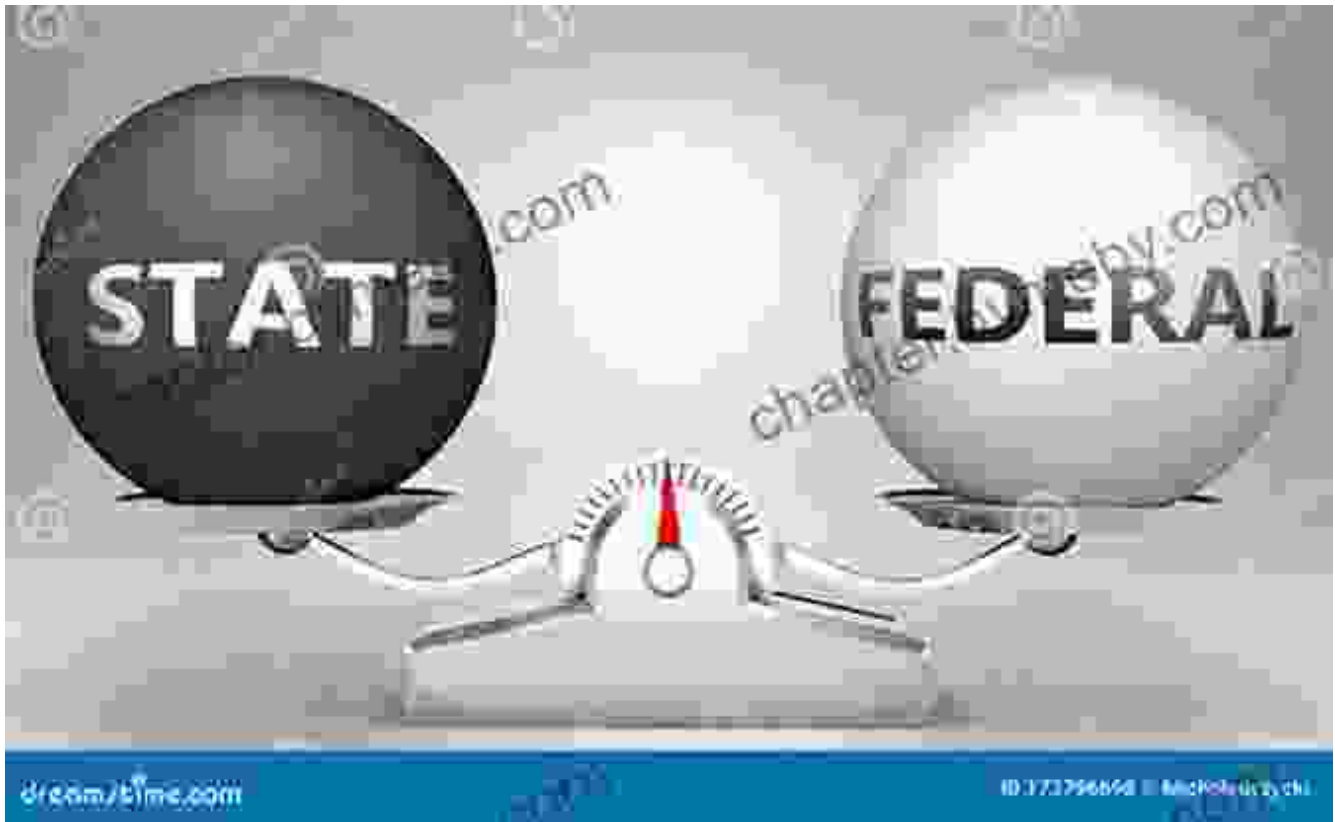
Amendment 9: Rights Not Enumerated

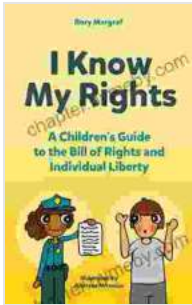

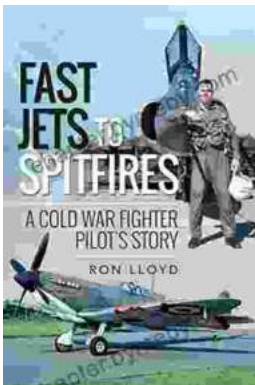
